






ZBAN OVERVIEW

We are Zambia's first business angels' network, established to fill a major gap in the entrepreneurship ecosystem and significantly increase the number of enterprises that can attract impact investment.

ZBAN is a positive contributor to the impact investment ecosystem supporting early-stage enterprises with a developed scalable model for starting and growing a local angel investment network.

ZBAN is a 'member-led' network of Business Angels – private individuals who invest their personal capital (finances, time, experience, contacts) in helping early-stage ventures to grow.

To oversee the development and implementation of effective mechanisms for the sustained growth and contribution of SMEs to Africa's economic development.

MISSION

To bring together individual capital, connections and mentorship for start-ups and early-stage enterprises.

GREG MARCHAND



Committees

ZBAN members play a huge role in moving the networks vision forward, one of the vehicles through which this is done is through member-led committees. Committees were formed in May 2022.

There are currently four main committees:

Pipeline Development led by Simunza Muyangana, Membership led by Connie Osborne, Resource Mobilisation & Events led by Greg Marchand and the Investment Committee led by Michael Tarney. Every network member is a member of at least one committee and contributes their expertise and skill to move each committees mandate forward. These committees have started meeting and putting down individual committee goals that feed into the overall ZBAN vision and mission.



The Secretariat

The Secretariat is the central operations and coordination arm of ZBAN. It is responsible for the execution of all ZBAN goals and plans.



<u>Pipeline:</u> It plays a central role in ensuring that a continuous flow of pipeline is assessed for viability and that once assessed the angels are given an opportunity to determine whether

<u>Communication:</u> they ensure that there is a constant flow of information from the start-ups,

Deal Flow: assist in initial process of deal flow management, provide preliminary paperwork such as term



sheets, where it might be between the investor and investee.

Relationship Management: monitor and manage investor/investee relationships.

> M & E: Monitor the progress that invested companies are making to assess economic impact.

Partnerships: establish and maintain partnerships within the ecosystem.

The Secretariat currently has two consultants: National Coordinator and Business Analyst. These consultants currently work remotely.


Coordinators Message:






